
- 1. Material: 1020 or 1045 or Q235(China material) Hot Rolled; Raw material thickness: 2.8mm Min.


- Burrs must be less than 0.2mm

INSTRUCTIONS

The wall on which the Bramec Bracket is installed must be a capable of supporting the weight of the air-conditioner condenser mounted on the Bramec Bracket. It is very important that the fasteners used are securely fastened and appropriate for the wall type. Attach the air-conditioner condenser unit to the Bramec Bracket by installing the appropriate fasteners using the holes that are provided. See illustration on reverse side for correct left and right mounting of the Bramec Bracket.

The size of the Bramec Bracket corresponds to the condenser unit size. Please allow a minimum of 6 inches or manufactures recommendations between the condenser unit and the wall.

It is recommended that vibration isolation be used between the air-conditioner condenser unit and the Bramec Bracket to reduce vibration and noise transmitted to the wall.
